

HOW WE WORK

Farm Journal Foundation acts as a connector and convener, bringing together stakeholders from across food and agriculture to advance solutions to pressing challenges. Our work has three main pillars: thought leadership, education, and issue engagement.



THOUGHT LEADERSHIP

We write and commission peer-reviewed policy research that offers tangible solutions to challenges across food and agriculture. We then elevate important ideas through op-eds, media engagement, speaking events, coalition building, and other strategic channels.



EDUCATION

We explain agriculture's vital role in feeding a growing global population through educational programs focusing on policymakers, students, consumers, and other key audiences.



ISSUE ENGAGEMENT

We work with a network of farmers, ranchers, and growers from across the U.S. to drive policy solutions to the biggest challenges facing food and agriculture today. The Foundation's team and our Farmer Ambassador network regularly host in-state events with federal policymakers and meetings on Capitol Hill to encourage public support for agricultural innovation, global food and nutrition security programs, agricultural development, veterinary workforce development, and other important initiatives.

2024 was a year of successes and new milestones. Below, we highlight some of our most important work of the past year.

POLICY ENGAGEMENT

Led by the inspiring work of the farmers and producers in our Farmer Ambassador program, we engaged with federal policymakers in Washington, D.C. and across the country. Our Farmer Ambassadors and staff held over 100 meetings with policymakers, and we hosted or participated in state-level events in multilple states, raising awareness about global food and nutrition security and its impact on U.S. economic opportunity and national security.













GLOBAL DISCUSSIONS

Farm Journal Foundation joined important conversations about global food and nutrition security and agricultural innovation on the international stage. In September, we hosted high-level events on the sidelines of the United Nations General Assembly in New York to elevate the importance of nutrition, and in November, we traveled to Baku, Azerbaijan to join the international dialogue and host events on the sidelines of the UN Climate Conference COP29.

This work helped to elevate farmer perspectives in important global discussions to ensure that solutions to food systems challenges work for everyone.

CONSERVATION **AGRICULTURE**

Farm Journal Foundation was proud to partner with the Howard G. Buffett Foundation this year to support communications and government affairs efforts at the Rwanda Institute for Conservation Agriculture (RICA). This institute of higher learning is promoting agricultural practices to increase soil health and food security in Rwanda and across Africa, and is inspiring the next generation of Rwandan leaders to serve their country through agriculture.







VETERINARY WORKFORCE **DEVELOPMENT**

Our work to address the national shortage of rural veterinarians had a break-out year in 2024. We kicked off educational pilots at nine universities, and three states joined our new State and Community Readiness program. Our Veterinary Ambassadors did a stellar job educating and building awareness about this important issue on Capitol Hill and beyond.



NEW PARTNERS

We kicked off our program, in partnership with the Intertribal Agriculture, Ecosystem Market Services, and the Yield Lab Institute, to support Native American cattle producers in implementing new conservation grazing practices. We are busy recruiting producers for the program in Montana, Florida, and Oklahoma, and we've organized and attended numerous events across the country to build awareness about the potential benefits of this program. By focusing on open communication in producer engagement and enrollment, we are concentrating on building opportunities for Tribal producers to actively participate in USDA conservation programs.



A NATIONWIDE NETWORK OF LEADERS IN AGRICULTURE

Farm Journal Foundation's flagship Farmer Ambassador program enables farmers, producers, and growers from around the country to engage federal policymakers in discussions about agriculture's biggest challenges. Farmers are agriculture's most effective advocates because they are on the front lines of our food system and have valuable firsthand knowledge about its challenges and opportunities. Farm Journal Foundation is proud to work with a group of Ambassadors who are innovators and leaders in their field, representing all aspects of American agriculture, including row crops, specialty crops, dairy, livestock, and aquaculture.



2024 POLICY AND LEGISLATIVE HIGHLIGHTS

In 2024, Farm Journal Foundation Farmer Ambassadors, Veterinary Ambassadors, and staff continued our extensive, strategic engagement of federal policymakers to advance priorities related to global food and nutrition security, agricultural research and innovation, and rural development issues. We held more than 100 meetings with officials across Congress and the executive branch to support strong funding and implementation of U.S. government initiatives in these issue areas.


Earlier in the year, we saw fiscal year 2024 funding finalized and passed into law by Congress. Although across-the-board funding cuts did result in a small decrease in overall funding for global food security and agricultural development programs, public agricultural research at USDA was held flat, and international agricultural research programs at USAID received a substantial increase compared with previous fiscal years. This funding included support for the Feed the Future Innovation Labs, CGIAR, and other investments that develop long-term solutions to challenges facing small-scale producers in lower-income countries, internationally and U.S. economic and national security interests here at home.

As of the end of 2024, Congress had not finalized fiscal year 2025 funding, but Farm Journal Foundation will continue to highlight the importance of robust investments in public agricultural research and the Feed the Future initiative, especially in areas that support international agricultural research and development, scaling of innovations to reach more producers, improved nutrition, and local private sector development to bolster food systems for the future. Farm Journal Foundation firmly believes in the lasting benefits of international agricultural research and development – we have seen time and time again that reductions in global food insecurity and malnutrition are tied to both U.S. national security and economic interests.

Regrettably, Congress was unable to pass a five-year farm bill in 2024. There were promising signals in the final weeks of December 2024 that there would be funding provided in a one-year farm bill extension for "orphaned" programs like the Foundation for Food and Agriculture Research (FFAR), which would allow that institution to continue to fund impactful public-private partnerships in agricultural research while leveraging on average an additional \$1.40 in private sector funding for every taxpayer dollar. Unfortunately, that one-year funding was not included in the year-end omnibus spending package, highlighting the continued urgency for Congress to pass a new five-year farm bill that invests in key agricultural research and development programs and also addresses the shortage of rural food animal veterinarians.

In 2025, Farm Journal Foundation looks forward to working with the new Congress and administration toward passage of a new five-year farm bill, appropriations bills, and additional legislation that supports farmers and producers by making robust investments in global food and nutrition security, agricultural research and innovation, and rural development. We also stand ready to partner with the U.S. government and explore new, innovative initiatives and investments – including through public-private partnerships – to advance these priorities and ensure U.S. national security and economic interests.

FARMER MEETINGS ON CAPITOL HILL

Farmer Ambassadors held numerous meetings in 2024 with members of Congress, legislative staff, and administrative staff, educating important stakeholders about the need to support agricultural innovation to improve global food and nutrition security.















FARM JOURNAL FOUNDATION HITS THE ROAD

Our in-state policy events engage with federal policymakers in their home states, showcasing the real world, local impact of agricultural development and innovation, and connecting that impact globally. These events reinforce conversations often started during our Washington, D.C. meetings, creating an opportunity for deliberate, one-on-one conversations with policymakers in their home settings.

In 2024, we participated in events with multiple members of Congress, administration officials, and dozens of Congressional staff. Events included farm tours, visits to agricultural research facilities, and deep conversations about how agricultural development and innovation benefit global food and nutrition security, national security, and the U.S. economy.

In August, we organized an event with Representative Rudy Yakym (R-IN) at Tom Farms, hosted by our Indiana Farmer Ambassador Kassi Tom-Rowland. At the event, we discussed the urgent need for greater investment in agricultural research and development to improve global food and nutrition security and, in turn, help ensure U.S. national security. The event included a fireside chat between Rep. Yakym and former U.S. Ambassador to the United Nations Agencies for Food and Agriculture Kip Tom, and was attended by farmers, industry stakeholders, and students.

In October, we organized an event with Representative Jimmy Panetta (D-CA) at Braga Fresh, hosted by California Farmer Ambassador Colby Pereira. The event included a visit to Braga Fresh's on-farm regenerative agriculture trials, demonstrations on how the farm uses agricultural technology, and a conversation on the importance of protecting soil health. The discussion highlighted how support for public agricultural development and innovation can benefit farmers in the U.S., as well as smallholder farmers overseas who produce the majority of food in many lower-income countries.






CONSERVING AGRICULTURE'S RESOURCES FOR **FUTURE GENERATIONS**

Farm Journal Foundation is committed to supporting farmers as stewards of the land, helping them adopt practices to protect natural resources and ensure the long-term viability of their operations. In the past year, Farm Journal Foundation continued its efforts

through the launch of a new conservation grazing program for Native American cattle producers in Oklahoma, Montana, and Florida, as well as our ongoing partnership with America's Conservation Ag Movement (ACAM). These programs work directly with farmers and ranchers to implement strategies that safeguard soil, water, and biodiversity, supported by technical assistance, education, and incentives from the USDA and other key partners.



In 2024, the Farm Journal Foundation, in partnership with our core project partners, made significant strides in advancing the pilot project for Tribal producers in Florida, Montana, and Oklahoma. The year marked a critical phase of outreach and engagement in collaboration with the Intertribal Agriculture Council, as we worked diligently to inform producers about the enrollment process, as well as the substantial benefits and incentives they would receive by participating. Through focused efforts, the project successfully held producer meetings on five different reservations. In Montana, these meetings were hosted on the Flathead Reservation of the Confederated Salish and Kootenai Tribes, the Blackfeet Reservation of the Blackfeet Nation, and the Rocky Boy Reservation of the Chippewa Cree Tribe. In Florida, meetings were conducted on the Big Cypress and Brighton Reservations of the Seminole Tribe at their Cattle and Range Offices. These engagements resulted in direct face-to-face outreach to 40 producers, and the project now has a total of over 85 producers expressing interest in project enrollment, aligning closely with our target goal of 70-100 producer participants.

> In addition to our producer meetings on reservations, we had the opportunity alongside our partners to share the project work with potential producer participants and other stakeholders at events including the Sustainable Agriculture Summit, National Grazing Lands Conference, and the Intertribal Agriculture Council Annual Conference.

The year was defined by strategic growth and responsiveness to producer feedback. Based on their input, we expanded conservation practice options available through the project, enabling producers to better meet their conservation goals. We also enhanced our technical assistance capacity by incorporating flexible service options provided by experts in rangeland management and environmental engineering, ensuring producers receive tailored, high-quality support. These efforts were conducted in close collaboration with USDA NRCS, reflecting our shared commitment to building pathways and relationships that will continue to benefit Tribal producers well beyond the lifetime of this project.

This work has set a solid foundation for the next steps of this project. By focusing on open communication in producer engagement and enrollment, we are concentrating on building opportunities for Tribal producers to actively participate in USDA conservation programs. As we prepare to launch formal producer enrollments, we remain dedicated to supporting producers in achieving their conservation and sustainability goals while empowering them to contribute to a strong future for their operations and their communities.

AMERICA'S CONSERVATION AG MOVEMENT



In 2024, Farm Journal Foundation continued its active partnership with the America's Conservation Ag Movement (ACAM), a collaborative coalition led by Farm Journal's

Trust In Food and the USDA's Natural Resource Conservation Service (NRCS). Together, the team strives to increase adoption of conservation practices among farmers. Building on previous years' successes, ACAM recruited five new farmer Conservation Stewards across five new states - Georgia, Louisiana, Montana, New York, and Oklahoma. Together with partners, ACAM hosted a series of field days, virtual peer networks, and other outreach events that provided local organizations and community members with opportunities to engage in candid conversations about conservation needs, challenges, and solutions. We look forward to our continued partnership with ACAM and Trust in Food as we connect with more farmer Conservation Stewards and grassroot organizations through on-the-ground events and beyond.

DEVELOPING RWANDA'S NEXT GENERATION OF LEADERS IN CONSERVATION AGRICULTURE

In 2024, Farm Journal Foundation began a partnership with the Howard G. Buffett Foundation to increase awareness and encourage the adoption of conservation agriculture practices on the African continent. Our work supported the Rwanda Institute for Conservation Agriculture (RICA) in its external communications and government affairs efforts, with the aim of elevating RICA as the primary thought leader on conservation agriculture in Rwanda.



RICA is a leading educational institution, founded by Howard G. Buffett with support from the Rwandan government, that is developing the next generation of African leaders to increase food security and serve their communities through agriculture.








PRINCIPLES OF CONSERVATION AGRICULTURE

Conservation agriculture is a set of farming practices that, when implemented together, improve soil health and lead to greater food security. Conservation agriculture practices include:

- · Minimal soil disturbance
- · Maintaining soil cover
- · Crop diversity
- Nutrient management
- Precision pest control
- Water efficiency
- Integrated farming systems
- Support for biodiversity

CHAMPIONING AGRICULTURE ON THE INTERNATIONAL STAGE

In 2024, Farm Journal Foundation hosted events on the sidelines of three major international conferences – the United Nations General Assembly (UNGA) in New York City, the World Food Prize Norman E. Borlaug International Dialogue in Des Moines, Iowa, and the UN Climate Change Conference, COP29, in Baku, Azerbaijan. All three events explored opportunities for how best to improve the productivity, livelihoods, and nutrition of smallholder producers around the world, especially those in low-income countries, as they battle food and nutrition insecurity in the face of extreme weather volatility. As Farm Journal Foundation's research has shown, improvements in global food security have multiple benefits for the U.S., supporting our national security, economic development, and trade.

At UNGA, we welcomed 2024 World Food Prize Laureate, Dr. Cary Fowler, to be the keynote speaker of our event titled Advancing Global Solutions: Elevating Nutrition to Reduce Hunger and Poverty. The event was co-hosted with Catholic Relief Services and

Center of the United Nations, right across the street from the UN headquarters in New York. Dr. Fowler was joined by the Honorable Samuel Kawale, Minister of Agriculture for Malawi and Brieuc Pont, French Special Envoy for Nutrition, along with a panel of experts.

Caritas Internationalis and took place at the Church

While in New York City at UNGA, our team also attended 15 other side events. Our Vice President of Government Affairs, Katie Lee, spoke on a Food Tank panel titled, Food and Agriculture is a Key Solution to the Climate Crisis, and focused on the roles of the private sector and farmers, investment, and donor community as catalysts for change. This event was supported by World Food Program USA.



Farm Journal Foundation also traveled to Des Moines. Iowa, for the World Food Prize. Our event, Avoiding a Collision: How We Can Both Nourish and Preserve Our World, featured a chat with author Roger Thurow about his latest book, Against the Grain: How Farmers around the Globe Are Transforming Agriculture to Nourish the World and Heal the Planet. His work explores how farmers in several major agricultural regions worldwide have faced famine, drought, and malnutrition, and how they've adapted their practices to work with nature. Following Thurow's keynote conversation with Farm Journal Foundation CEO Tricia Beal, attendees heard from a panel made up of leaders of international organizations including CGIAR, USAID, and GAIN.

COP29 rounded out our international engagement for the year. Farm Journal Foundation led and engaged in several events during the conference to ensure that agriculture and farmers were elevated and viewed as part of the solution in critical global conversations. Farm Journal Foundation's Senior Policy Adviser, Rose Barbuto, led our flagship event, Climate-Smart Solutions for Smallholders: Taking Stock of Progress and Future Opportunities in Agriculture, featuring Farm Journal Foundation's Farmer Ambassador from Arkansas, Brad Doyle, and leaders from USDA, CGIAR, Bayer, and One Acre Fund. The event focused on the steps the U.S. is taking to invest in agricultural research and development to improve food and nutrition security, reduce poverty, and help mitigate climate impacts, while showcasing programmatic examples of solutions that have scaled among small-scale producers to help them build more resilient local food systems. In addition, our team hosted a private roundtable discussion session with the bipartisan Senate Staff Delegation and key leaders in global agriculture. Senate staff were able to ask questions and actively learn more about U.S. foreign assistance investments in agricultural development and innovation drive impact and address global challenges. Also in Baku, Rose was asked to moderate several other big events on the sidelines of COP29 with BIO, Solutions from the Land, Business Sweden, and GAIN.



LEADING CONVERSATIONS ON **GLOBAL ISSUES**

POLICY RESEARCH

How Climate Change Impacts Nutrition Security in Low- and Middle-Income Countries.

The Farm Journal Foundation team, in partnership with Cornell University researchers, released a policy paper in 2024 titled How Climate Change Impacts Nutrition Security in Low- and Middle-Income Countries. The paper touched on a series of challenges – COVID-19, regional conflicts, and climate change – that are negatively impacting food and nutrition security worldwide, then offered policy recommendations for the U.S. government to support global nutrition security.



In May, the Farm Journal Foundation team hosted a paper launch event on Capitol Hill where USAID Chief Nutritionist, Dr. Patrick Webb, led a fireside chat with paper authors Dr. Ramya Ambikapathi and Daniel Mason-D'Croz from Cornell University. Rep. Marc Molinaro (R-NY) wrapped up the event, speaking about how the recommendations presented in the paper play a role in U.S. national security and economic stability, and how U.S. policymakers could affect positive change.

Feeding the Future: Leveraging Agriculture for Better Diets and Nutrition

Farm Journal Foundation partnered with Catholic Relief Services on a project to reduce global malnutrition through improved nutrition-sensitive agriculture programming in U.S. government efforts like the Feed the Future initiative. This included a policy paper produced by Catholic Relief Services titled Feeding the Future: Leveraging Agriculture for Better Diets and Nutrition, as well as a

case study in Ethiopia. Key recommendations in the paper included better prioritizing nutrition and diet-related goals, indicators, and pathways; supporting women's economic empowerment; investing in research and impact analysis with special attention to provide guidance to practitioners; and other key interventions. An advisory committee of leading stakeholders from across nutrition and agriculture helped guide and inform the project and paper, which was formally launched at a side event at the United Nations General Assembly.

DEVELOPING SOLUTIONS FOR **AMERICA'S RURAL VETERINARY WORKFORCE**

Our Veterinary Workforce Solutions Program wrapped up its third year in 2024, working hard to address the shortage of rural, food systems veterinarians across the country. This program focused on three main pillars in 2024: state and community readiness, student and young professional development, and issue engagement through our Veterinary Ambassador program.

STATE AND COMMUNITY READINESS

Three states made commitments to pilot our State and Community Readiness infrastructure - Oklahoma, Kansas, and Indiana. We are working in partnership with the National Association of State Departments of Agriculture (NASDA) to collect state data and information to assess each state's situational needs.







STUDENTS AND YOUNG PROFESSIONALS

In addition, the education-focused pilots kicked off at nine universities in 2024: Auburn University, Iowa State University, Kansas State University, Lincoln Memorial University, Mississippi State University, Oklahoma State University, Penn State University, Texas Tech University, and Tuskegee University. These pilots are helping students learn how to tackle student debt and financial planning, develop business management skills, and learn how to engage with rural communities. Participants also receive advice from Farm Journal Foundation's Veterinary Ambassadors. To date, the pilot program has reached 450 students and early career professionals.

Coming up in 2025, we will be piloting a version of our educational modules in high schools with agriscience educators focused on career exploration within rural and food-system veterinary careers.





















VETERINARY AMBASSADOR PROGRAM

In 2024, our Veterinary Ambassadors spent time on Capitol Hill, engaging in 28 meetings with legislators from multiple states and hosting a Lunch-N-Learn for staffers to learn more about our Rural Veterinary Workforce Solutions Program. We also added one new Ambassador, Dr. Timothy Goldsmith, a professor within the Ruminant Division at the University of Minnesota, College of Veterinary Medicine.


